Bill W. Miller of Sherman, TX passed away Jan. 20. 2013 in the Medical Center of Plano, TX at the age of 82 years.

He was born Aug, 27, 1930 in Fayetteville, AR, a son of the late Hallie and Dollie Skelton Miller.
